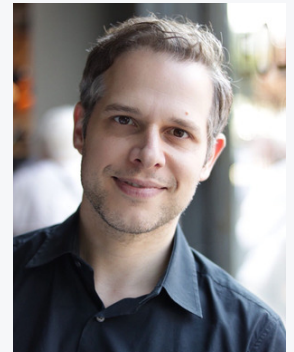
Crypto: venture into the unknown

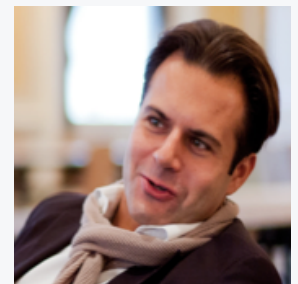
